This is a Handicap tournament open to teams of 5 bowlers. Any combination of men or women. Maximum team average of 1075.

Prize Money will be mailed by Friday following the tournament.

#### BROUGHT TO YOU BY THE MISSOURI STATE BPAA

- 1. Teams of 5 may bowl. All teams will bowl 3 games. Any combination of USBC, BA, or WBA Sanctioned bowlers per team. USBC Bowler ID number must be provided on the entry form. Only one card carrying Pro per team.
- 2. MAXIMUM AVERAGE FOR ENTERING TEAM MAY NOT EXCEED 1075.
- 3. Average to be used in tournament will be the highest book average from 2018-2019 of 21 games or more. If no 2018-2019 book average, then bowlers must use the highest 2019-2020 current average of 21 games or more. All others will bowl scratch using a 215 average. TEAM WILL BE DISQUALIFIED IF ANY BOWLERS FAIL TO COMPLY TO THIS RULE. TEAM ENTRY FEE WILL BE FORFEITED WITH DISQUALIFICATION. Sport league average is not accepted.
- 4. Handicap is 80% of the difference in the team total average from 1075.
- 5. There is no absent or blind score. A tardy bowler may bowl, but will receive zero for the missed frames.
- 6. Monthly tournament cash payback is a ratio of 1 in 5. Teams may cash once with the same 5 bowlers each month. Teams must switch at least two bowlers to cash more than once.
- 7. 1 in 8 teams qualify for the State Finals each month. Teams may qualify more than once for the State Finals and may bowl as often as they have qualified if scheduling permits. Each qualifying team may cash once at the State Finals with the same 5 bowlers. In order to cash more than once, each qualifying team must change at least 2 bowlers from the original qualifying team. There is a \$130.00 entry fee for the teams that qualify for State Finals.
- The tournament will be sanctioned by USBC and will abide by all rules not covered herein.
